# Why Cyprus belongs on a serious buyer shortlist.

Cyprus is compelling because a single acquisition can support family lifestyle, seasonal use, rental operation, future relocation and long-term portfolio diversification. The right property is selected by mandate, not by listing noise.

### Lifestyle utility

Usable beyond peak summer, with airport access, services, restaurants and everyday comfort.

### Capital discipline

Scarcity, title clarity, micro-location and buyer depth matter more than headline decoration.

### Rental readiness

Guest flow, furnishing, management and local rules decide whether income assumptions are realistic.

### Relocation optionality

School access, healthcare, banking and advisor coordination can turn a second home into a base.

## Buyer filters

Filter	Why it matters
Location scarcity	Sea views, marina access, walkability and established prime demand can protect long-term desirability.
Legal clarity	Title, permits, contract terms and completion obligations should be reviewed before commitment.
Management readiness	Absent ownership needs maintenance, keyholding, furnishing and service-provider planning.
Exit liquidity	The next buyer pool should be considered before paying for emotional extras.



LOCATION INTELLIGENCE

# Different Cyprus markets serve different mandates.

A prime Cyprus search should compare how each location behaves for lifestyle use, rental demand, resale depth and owner convenience.

Area	Market character	Best-fit mandate
Limassol	Urban waterfront, business demand, marina lifestyle.	Executives, city yield, lock-up-and-leave.
Paphos	Golf, villas, family relocation, established international depth.	Lifestyle villas, long stays, west-coast living.
Larnaca	Airport convenience, beachfront projects, coastal momentum.	New-build buyers, practical access, staged investment.
East Coast	Beaches, holiday demand, private villas.	Seasonal rental, family holidays, resort lifestyle.
Nicosia	Capital city, education, business and diplomatic demand.	Long-let profile, city base, education-led stays.

The same budget can buy very different risk and enjoyment profiles. Micro-location, access, views, parking, building condition and management route matter more than broad city labels.



## ACQUISITION PROCESS

# A calm route from shortlist to handover.

## DUE DILIGENCE

# Questions serious buyers should answer before commitment.

Cyprus Legacy coordinates real estate context; final conclusions should come from independent legal, tax, valuation, financing and technical advisors.

Category	Questions to check
Title and permits	Title deed position, planning and building permits, developer or community obligations.
Financial exposure	VAT or transfer-fee treatment, service charges, sinking fund, insurance, maintenance and management costs.
Rental operation	Local rules and licensing context, furnishing budget, guest-readiness and independent rental appraisal.
Technical condition	Independent survey, pool, mechanical/electrical/plumbing, waterproofing and future capex requirements.
Ownership structure	Tax, residency, financing and cross-border ownership considerations with qualified advisors.
